In compliance with the LACMA By-Laws & Regulations, Code of Ethics, and Norms, Rules & Procedures, the LACMA Board of Directors has defined the **expulsion** of the above-cited member due to the non-compliance of the following:

LACMA BY-LAWS TITLE III - THE MEMBERS Article 15: Membership will be lost by the following: e) For failure of payment of financial obligations to the association and/or other members of the association. f) For violating or acting against the By-laws, Regulations, and Code of Ethics of this association.

REGULATIONS OF THE LACMA BY-LAWS TITLE I, ARTICLE 2, PARAGRAPHS C, D, AND G Claims, LACMA Guarantees & Sanctions *F. If the instructions defined by the LACMA Supportariat*. *Arbitration*

F. If the instructions defined by the LACMA Secretariat, Arbitration Committee and/or Board of Directors are

not met, the latter may apply one or more of the following sanctions, which will also be applicable in the event of a lack of response from the affected parties. **F.5** Definite expulsion with publicity in LACMA's communication means for a period of one (1) year.

LACMA CODE OF ETHICS

1. To respect and observe the by-laws and regulations of the association and fulfill the obligations stipulated in them.

NORMS, RULES & PROCEDURES Article 1: Responsibility

With the LOSS of the LACMA AFFILIATION, SGRS MOVE MANAGEMENT (Switzerland), LOSES ALL RIGHTS in regards to the ASSOCIATION.

As per the LACMA PGP Regulations, LACMA will grant a period of **30 days** (July 25 - August 24) for the presentation of SGRS pending invoices, in compliance with the LACMAPGP.
