

LACMA Rewards

Terms and Conditions

1. The **LACMA Rewards program** is for the participation of: Active, Associate, and Industry Supplier members, duly registered who aren't under any temporary suspension or membership withdrawal.
2. The participation in the **LACMA Rewards program** is subject to the Terms and Conditions listed herein, which apply universally, unless otherwise specified.
3. The participation in the **LACMA Rewards program** is subject to the rules, regulations, and policies that LACMA may, at its discretion, adopt at any time. LACMA may modify the program rules at any given moment without notice. LACMA counts with the complete authority to interpret and apply the Rules and Regulations of this program.
4. Each member participating in **LACMA Rewards** is responsible for reading the rules of the program, the newsletters and consulting their account status and their rewards history on the LACMA website to comprehend his/her rights, responsibilities, and status in the Rewards Program, as well as the process to obtain said rewards.
5. The process to obtain LACMA Rewards is subject to modifications, cancellations, and limitations, at LACMA's discretion, with or without previous notice. The amount of points necessary to use your Rewards may increase; any given reward may be terminated and/or may suffer restrictions for the reward itself or the redemption of it at any time.
6. LACMA has the right to terminate the **LACMA Rewards Program** at any given moment with a written notice to its membership six (6) months prior to the termination date of the LACMA Rewards program. If this is the case, the right to obtain points and redeem them, can be finalized six (6) months after the notification, regardless of the participants' duration in the LACMA Rewards Program. LACMA may finalize the program totally or partially in any jurisdiction.
7. **POINTS / VALUE:** 1 LACMA Reward point equals US\$0.50 (fifty US cents).
8. **POINTS EXPIRATION POLICY:** Points are valid for two (2) calendar years from the year in which they were earned. Unused points will remain valid for two (2) years from their earned date.
9. **POINTS EARNING POLICY:** The following activities generate points as long as their payment has been correctly processed:
 - a. **Advertisement:** generates 5% of the total cost in points.
 - b. **Virtual and On-Site Seminars:** generate 3% of the total cost in points.
 - c. **Convention:** generates 10% of the **total registration cost** in points (does not apply to LACMA Certified Packers Training/Certification)
 - d. No points will be generated from the registration to other activities of the Convention (LACMANext Party and/or Activity, Green Walk, Golf, etc.)
10. **POINTS REDEMPTION POLICY:** Points may be redeemed only by registration and participation in the Annual Convention and/or Seminars (Virtual and On-site), and advertisement (magazine, newsletters, and website) duly paid, based on the conditions described below:
 - a. **LACMA CONVENTION:** Points are redeemed from the 2nd. participant registration and up to 50% of the total price of said registration (does not apply to discounted rates nor to other additional activities). If there are remaining points, up to 50% of the total registration cost of the 3rd participant onwards may be applied.
 - b. **SEMINARS:** Points are redeemed from the 1st participant in the case of in-person and/or virtual seminars (does not apply to LACMA Certified Packers Training/Certification).
 - c. **ADVERTISING:** Points may be redeemed in any advertising option (magazine, newsletters, and website).
11. LACMA reserves the right to redeem, revoke, cancel, or suspend any participation in the LACMA Rewards Program, as well as the right to take any action at its discretion, at any given moment, effective immediately without written notice or obligation to any member, if the association considers that: The Member (1) has violated any rule of the program; (2) has not paid an invoice or bill owed to LACMA (3) has not acted according to the rules, laws or regulation; (4) has demonstrated inappropriate conduct or any wrongdoing in connection

with the LACMA Rewards Program (5) has shown some abusive, fraudulent, inappropriate or hostile behavior in relation with the LACMA Rewards Program.

12. The LACMA Rewards Program will be managed only and exclusively by the LACMA Secretariat.
13. The points can't be transferred from one company to another, or from one member to another. Points belong exclusively to the member/company who participated in the activity that generated the points initially.
